City of Bridgman, MI Weko Beach Dune Restoration Project

Sealed Bids for the construction of the Weko Beach Dune Restoration will be received by the City of Bridgman at the Bridgman City Hall, 9765 Maple Street, Bridgman, MI 49106 until **11:00 am, August 27, 2021**, at which time the Bids received will be publicly opened and read. The Project consists of removal of existing retaining walls, installation of sheet pile walls, installation of sand trap fence, and installation of restoration plantings.

Bids will be received for a single prime Contract. Bids shall be on a unit price basis. Sealed Bids bearing the project name as well as the name and address of the bidder shall be submitted to **Sara Ball, Parks and Recreation Director, City of Bridgman, 9765 Maple Street, Bridgman, MI 49106**

An additional Ten Dollars (\$10.00) will be charged for plans requiring shipping. General Specifications, description and conditions upon which the bid proposal is to be based are on file for examination at the office of the Engineer, Abonmarche, 95 West Main Street, Benton Harbor, MI 49022.

A certified check, cashier's check or bid bond in an amount equal to five percent (5%) of the total amount of the bid, made payable to the City of Bridgman will be required with each bid as security for the proper execution of the contract. A 100% Labor, Material, and Performance Bond will be required of successful bidder.

A Pre-Bid Meeting will be held at 10:00 am, August 18, 2021 local time at the Weko Beach House, 5301 Lake Street, Bridgman, MI 49106

No bid shall be withdrawn for a period of sixty (60) days after the scheduled opening without consent of the OWNER. The Owner reserves the right to reject any and all bids, waive any informality in bidding or to accept the bid, consistent with law, which best serves the interest of the Owner.
